**GENERAL INFORMATION**

An **Application for Game Room Permit** must be included with this form. All licenses for coin-operated amusement machines are payable annually in advance. Prior to the placement by an owner of a coin-operated amusement machine in operation at a location, there shall be attached thereto a valid city Occupation Tax Tag for the machine. Each coin-operated amusement machine is subject to the annual occupation tax when placed in operation in the City. The following License & Occupation Tax Tag Fee will be applied to a coin-operated amusement machine which is placed in operation in the City:

**Amusement Center License Fee: \$750.00**  
**Occupation Tax Tag Fee: one-fourth amount levied by State**  
**(Jan- March) \$60.00 (State) \$15 (City)      (April- June) \$45.00 (State) \$11.25 (City)**  
**(July- Sept) \$30.00 (State) \$7.50 (City)      (Oct- Dec) \$15.00 (State) \$3.75 (City)**

*Each coin-operated amusement machine shall be registered with the City by make, model, serial number and location. A tag issued by the city shall be affixed to each such registered machine.*

**INSTRUCTIONS FOR PREPARING MACHINE INVENTORY**

Attach to this form a complete list by make, model, serial number and location of all the coin-operated amusement machines for which you are purchasing tags. **Do not** include coin-operated cigarette, service, and merchandise vending machines, or coin-operated amusement machines designed exclusively for children. Determine your total Occupation Tax Tag fee by multiplying the total number of machines by one-fourth (1/4) the amount levied by the State.
