Permit Fee: \$35

1. Prior to installation, please check with City of Liberty staff to see if a manufactured home is allowed on your lot.
2. The manufactured home information sheet must be included with your application.
3. There shall be only one manufactured home per lot.
4. Proof of ownership or rental agreement of the property must be provided.
5. If your manufactured home is located in Flood Zone A or Flood Zone AE per the Flood Insurance Rate Map (FIRM), you must include an elevation certificate with this application.
6. All Manufactured Homes must meet and comply with the following standards:
 - a. Age: The manufactured home may be no more than ten (10) model years old and must meet current HUD-Code requirements.
 - b. Foundation: The manufactured home must be placed on a permanent concrete foundation: concrete slab or concrete runners.
 - c. Lot Size: The manufactured home must be placed on a lot that is a minimum of 50' x 100'.
 - d. Skirting: The manufactured home must be skirted with a solid material before any utilities will be connected: Materials such as wood, plastic, vinyl, or masonry can be used as skirting
 - e. Site Plan: Applicant must submit a site plan showing, at a minimum, the lot size, setbacks and parking spaces for the manufactured homesite.
 - f. Driveway & Parking: Must have a paved driveway connecting to a public or private street. Driveway must be capable of supporting a minimum of two (2) vehicles.
7. The following permits are issued separately (additional fees apply for these permits):
 - a. Electrical Permit
 - b. Plumbing Permit
 - c. Mechanical Permit

Note: Electrical and plumbing work may only be performed by the homeowner when the property is listed on the tax rolls as their homestead. HVAC and manufactured home installation must be performed by registered and state licensed contractors.

8. Your permit must be approved and issued by City staff before the manufactured home is installed.
9. Compliance with these standards will be verified by the City of Liberty Building Official or his or her designee.
